REVIEW OF *THE HEALING* BY
JONATHAN O'DELL

Jonathan O'Dell was formerly from Mississippi, and is now living in Minnesota. The author has many not-so-fond memories of bigotry and intolerance of blacks and their struggle for civil rights. He knew it was not just their story but his as well since bigotry was a part of his culture. Growing up in the South, O'Dell was aghast at the treatment blacks received at the hands of whites. His new book tells of the bonds between three generations of plantation slaves in the pre-Civil War era. These female slaves were healers who filled both psychological and spiritual roles and used their power to heal both body and soul.

I believe it is a book that you won't be able to put down, even though you'll read about cholera, comedy, mystical qualities, cures, and the delivering of babies by midwives on a cotton plantation.

In *The Healing* one of the healers believes that the slaves are merely soul sick and also quite starved as they are eating mostly molasses, corn bread, and fat back. The powers that be insist that the slaves are without a soul and treating them like field animals is the normal mode by the overseers and others.

Black midwives were accustomed to listening and also "catching" (birthing) babies. Their skills in midwifery were of much interest to me and how they passed their knowledge to others. These midwives practiced what was passed down from Africa and served many functions in their communities through the Jim Crow days in the South. The demise of prominence of these women started in the 1950s when the white medical establishment discredited them and required licensure for them. Often the women were portrayed by the medical doctors as dirty, ignorant, superstitious, and unable to read.

There are several books about midwives and health care practiced in the South listed in the acknowledgments which I have purchased. One that I found most interesting was *Listen to Me Good: The Story of an Alabama Midwife*.

The release of a new study on the social and economic effects of widespread use and availability of no-cost contraceptives was released earlier this month, taking the country by storm. The Contraceptive Choice Project, a four-year experiment conducted by Washington University in St. Louis, Missouri, provided free contraceptives to over 9 thousand women in the St. Louis area, primarily low-income or uninsured. As a result, the rates of abortions in the area decreased dramatically, dropping 20 percent from 2008 to 2010, while the rate of abortion in the rest of Missouri remained unchanged. Repeat abortions also decreased from 47 percent in 2006 to 39 percent in 2010, while in Kansas City, Missouri during the same time period, the rate of repeat abortions increased by 8 percent. Teen pregnancy among 15-19 year old girls enrolled in the project numbered 6.3 per 1,000, compared to a national average of 34 per 1,000.

According to the researchers, the project, begun in 2007, was intended to model the potential benefits of the insurance coverage mandate of the 2010 health care law. It is generally understood that birth control can prevent unwanted pregnancy, however women who want to use contraception can face a number of obstacles, including but not limited to cost. This research showed that when cost is not a factor most women - 75 percent of study participants - will choose a long-acting method of contraception such as the increasingly popular (but often expensive) IUDs. This is the largest and most expansive study of its kind and should dramatically change the controversy surrounding use of contraceptives. Anti-choice groups have however, already come out against the reputable study, grasping for whatever opposition they can. Their unsubstantiated claims are being mostly ignored.

PRESIDENTIAL TICKETS: STARK CONTRASTS ON REPRODUCTIVE JUSTICE ISSUES

The social media universe is atwitter with spin-masters and fact-checkers getting out their messages on where the presidential and vice-presidential candidates stand on issues affecting women. The most contentious issues – those affecting women’s reproductive rights and health – also offer the starkest contrasts. Let’s look at where Obama-Biden and Romney-Ryan stand, based on their actual words and positions they’ve actually taken.

Roe v. Wade and safe abortions

The U.S. Supreme Court decided in *Roe v. Wade* in 1973 that women have the qualified Constitutional right to decide whether to terminate their pregnancies. It found that a Texas law making abortions illegal except to save the life of the mother violated women’s constitutionally protected right to privacy under the 14th Amendment. However, the Court also decided, and has affirmed since, that states have interests regarding the pregnant woman and her fetus that may justify regulating abortion. The scope of the government’s power to do so remains the subject of intense debate and controversy, both in the courts and in national and state legislatures.

The first question we must ask is where the candidates for President stand on *Roe v. Wade*. What philosophies might they look for in their nominees the Supreme Court and other federal courts? What are their positions on keeping abortion safe and legal?

Many states have anti-abortion laws that would automatically take effect if *Roe* were to be overturned, and many more stand ready to adopt similar laws. According to a 2004 report by the Center for Reproductive Rights, women in 30 states risk losing access to safe and legal abortions in their states.

President Barack Obama released a statement on the anniversary of *Roe v. Wade* this year, reaffirming his commitment to protect a woman’s right to choose. He stated that, [T]his Supreme Court decision not only protects a woman’s health and reproductive freedom, but also affirms a broader principle:

that government should not intrude on private family matters.” As an Illinois state senator, as a U.S. senator, and as a candidate for president in 2007-2008, Obama has opposed limitations on government funding of abortion. He has opposed the Hyde Amendment, first enacted in 1976, to bar federal funding of abortion except in limited circumstances -- rape, incest, or where the life of the mother is in jeopardy. Hyde’s major effect is to prevent low-income women from having abortions paid by Medicaid. However, it’s language has been adopted for many other federal programs.

Vice-President Joe Biden’s positions have changed somewhat over time. He long supported the Hyde Amendment as a U.S. Senator. In 1982, he supported a resolution for a Constitutional amendment that would have effectively nullified *Roe V. Wade*. However, in his recent vice-presidential debate with his opponent Ryan, Biden stated strongly that, while he is personally against abortion for religious reasons, he believes that neither he nor anyone else has the right to inflict those beliefs on women.

Obama has shown what sort of judicial nominees he favors, by appointing two liberal-leaning women to the Supreme Court – Elena Kagan and Sonia Sotomayor. Most court observers believe that neither would vote to overturn the Constitutional protections enunciated in *Roe*.

Both Mitt Romney and his running mate Paul Ryan have long opposed abortion rights (although Romney switched his position from being pro-choice, when running against the late Sen. Ted Kennedy for the Senate). Ryan has stated, “I am as pro-life as a person gets,” consistently voting in Congress against a woman’s right to choose, and opposing abortion even for women who have been raped.

Romney has stated that he would nominate judges to overturn *Roe v. Wade*, and allow each state to make its own laws making abortion illegal, as Texas had done in the *Roe* case. A Romney statement quoted on his website is that, “I would expect every one of my appointees

to carry out my policies on abortion...” Ryan telegraphed his agreement with Romney when asked, “If the Romney-Ryan ticket is elected, should those who believe that abortion should remain legal be worried?” His response was, “We don’t think that unelected judges should make this decision...”

Romney has officially made a “pro-life pledge,” not only reiterating his opposition to Roe, but also pledging:

- (1) his opposition to abortion in all circumstances except rape, incest and when necessary to save the life of a mother;
- (2) his support for the Hyde Amendment ban on the use of federal funds for abortion;
- (3) his support for a ban on federal funding for Planned Parenthood and any other domestic organization that performs abortions; and
- (4) his support for the Mexico City Policy, which bars U.S. funding for non-governmental organizations that provide family planning services overseas if they perform, promote or advise women about abortion.

Romney has also said that that he would “eliminate Title X family planning programs,” which provide federal funding for birth control and cancer screenings. He flatly takes the position that life begins at conception; as Massachusetts governor, he vetoed a bill that would have allowed stem cell research using embryos and a bill giving rape survivors information about and timely access to emergency contraception.

Further, Romney and Ryan have also staunchly supported barriers to women exercising their Constitutional rights, so as to restrict access to abortion. Ryan has actively supported federal legislation that would require mandatory waiting periods and intrusive intra-vaginal ultrasounds before a woman can terminate her pregnancy, even against her will.

Access to affordable birth control Obama’s signature administrative action on behalf of women’s access to affordable birth control was issuing regulations under the Affordable Care Act that -- with the exception of churches and other places of worship -- will require all U.S. employers to fully cover the cost of contraception in health insurance coverage for the women they employ. His

administration rejected the religious community’s call to broaden the exemption to include all faith-affiliated organizations, such as Catholic hospitals and universities. The rule was modified to accommodate continuing objections, to allow an exemption for religious organizations so that they do not directly pay for contraception, while requiring that their employee health plans offer and themselves pay for contraceptive coverage.

Romney and Ryan take the opposing position -- that the ACA regulations on employer-provided contraceptive coverage should not be allowed to stand, because they violate the religious liberties of faith-affiliated organizations. (In fact, Romney opposes the entire health reform law, and has vowed to repeal it were he to become President. He has made somewhat conflicting statements suggesting that he might support certain consumer protections contained in the ACA, without giving details as how he might do that.)

So, the contrasts are clear. The candidates for President have divergent views on Roe, on abortion and abortion regulation, and on access to contraception. Whichever one is elected will help shape our nation’s laws far into the future. Citizens for Choice is a nonpartisan organization and does not endorse or oppose any party or any candidate for public office. ▶▶WOMEN USE CONTRACEPTION TO BETTER ACHIEVE THEIR LIFE GOALS▶▶

New evidence confirms what most people already believe: Women use contraception because it allows them to better care for themselves and their families, complete their education and achieve economic security, according to "Reasons for Using Contraception: Perspectives of U.S. Women Seeking Care at Specialized Family Planning Clinics," by Jennifer Frost and Laura Lindberg of the Guttmacher Institute. "Women value the ability to plan their childbearing, and view doing so as critical to being able to achieve their life goals. They need continued access to a wide range of contraceptives so they can plan their families and determine when they are ready to have children."

The majority of participants reported that contraception has had a significant impact on their lives, allowing them to take better care of themselves or their families (63%), support themselves financially (56%), complete their education (51%), or keep or get a job (50%). View the report online.

Many of you were probably Girl Scouts as children, as I was. Some of you might even have served as Girl Scout leaders, sold or bought cookies, or supported them in other ways. This month one of our local sister groups, SeeJaneDo (SJD), had a tentative plan with the Girl Scouts Heart of California Council (GSHCC), based in Sacramento, to let them have a booth at SJD's Passion into Action Conference where they could broadcast their message, show videos, and recruit young girls into the Scouts.

But when the "adults" at GSHCC saw the conference program materials, they saw that one of the 30-some speakers listed was a former Executive Director of Planned Parenthood. They immediately wrote SJD and cancelled their participation, saying "We will not share a platform with the former CEO of Planned Parenthood and will not be able to promote the conference." Efforts by SJD and local supporters to ask the GSHCC Board of Directors to reconsider or at least further discuss this decision were stonewalled, even though the speaker in question hasn't been with Planned Parenthood for seven years!

The point is, here we have yet another example of what happens when fear stops everything, paralyzes otherwise competent people and keeps them from doing something that would benefit those they claim to serve. GSHCC's fear of possible criticism from extremist voices on the right, who might allege a false affiliation between the Scouts and Planned Parenthood, has stolen an opportunity for more of our local young girls to learn, grow, and thrive as Girl Scouts. The mere threat posed by the fact that a long-ago former director of a group espousing women's right to choose is one of 30-some speakers at a conference means GSHCC can't participate. Isn't this a sad state of affairs? What can we do to keep this modern-day McCarthyism from stealing opportunities from future generations? Let's think about this....
