

OUR TEENS AND SEX

How are the teens in your life going to learn about sex? Some parents see the awkward coming-of-age time in a teen's life as an opportunity to have a comprehensive conversation about sex. They feel it's their responsibility as parents to introduce the conversation. For other parents, though, the thought of a sex talk makes them want to ignore that it's a real possibility or run far, far away—at least until dinner time.

Parents use a variety of tools to approach their teens: love, empathy, science, and sometimes fear, threats and guilt. "Teens and sex" is a topic about which we all have unique approaches. When a parent is comfortable talking about sex with their teen, the focus is on compassion, health and safety, and really listening to your teen. The goal is to offer teens the opportunity to consider their own personal thoughts, commitments and objectives around sex and their health.

Citizens for Choice wishes every parent and teen were able to have honest communication about sex. We prefer parents reach out to their teens and offer accurate medical

information and assist them in obtaining necessary reproductive health services. We want teens to feel safe and empowered to talk to their parents about sex and how they navigate this time in their lives.

But let's be honest—not every parent or teen is comfortable with The Conversation. There is no shame in that. Sometimes the conversation is not going to happen at home. That's where Citizens for Choice gap. There is no recipe for the "right" way. The goal is to get your teen the information they need to make healthy reproductive health choices for themselves.

Don't feel comfortable having a conversation with your teen about sex? There are options! Please let them know about The Clinic! right here in Grass Valley, located at 120 Richardson Street. A licensed RN as well as certified Health Workers are available to answer any questions, in addition to the free/low cost services The Clinic! provides. We are open on Mondays and Wednesdays and turn no Kimberly D'Urso one way. Rest assured that your teens will

get medically accurate information and the support of a knowledgeable and caring staff.

There are also online resources you can share with your teens or use as a tool to introduce a conversation about sex. Some helpful resources are: teensource.org, to learn about healthy/unhealthy relationships, learn legal rights, research birth control methods, or understand more about the risks of STDs; sexetc.org, a site written by teens for teens; hopes to help parents and teens bridge that and plannedparenthood.org/teens, a site written by Planned Parenthood dedicated to teens.

COURT RULES AGAINST CHALLENGE TO CRISIS PREGNANCY CENTERS LAW

Citizens for Choice supports the law AB 775 Reproductive FACT Act passed last year which:

Requires certain licensed providers of pregnancy-related services to provide specific information (by posting or distributing) to those served about their reproductive health rights, including:

(1) rights under the Reproductive Privacy Act to use birth control, bear a child or have an abortion; and (2) health insurance coverage of reproductive health services for lower-income individuals, with a contact phone number.

Further requires unlicensed providers of pregnancy-related services to clearly post and include in their advertising a statement that they are not medical facilities licensed by the state of California and do not have a licensed medical provider on staff.

One reason the bill is needed is to make prospective and current clients of crisis pregnancy centers aware that the centers are not medical facilities, are not licensed, and do not provide prenatal care or comprehensive reproductive healthcare or referrals. Noncompliance by either type of facility is subject to fines: \$500 for the first violation if not corrected within 30 days, and \$1,000 for subsequent offenses.

As of October 2016, in the federal case involving the Nevada County crisis pregnancy center (Livingwell Medical Clinic v. Harris, Northern District of California), Livingwell's appeal of the denial of a motion for a preliminary injunction is pending before the 9th Circuit.

Deciding at an early stage in another of the three cases to go to the federal appeals court, the Ninth Circuit in mid-October preliminarily rejected that argument. It denied a preliminary injunction blocking implementation, thus allowing the case to proceed to a full trial on the same question. A similar result is expected in the Livingwell case.

CALIFORNIA BILLS ADVANCING EQUITY AND HEALTH ACCESS

We at Citizens for Choice are pleased to announce another very successful legislative session for us, in terms of promoting reproductive health and access in California. Virtually all of our advocacy priority bills have passed and become law. Most will go into effect on January 1, 2017.

We have already pointed to the repeal of the Maximum Family Grant rule as a singular achievement to increase opportunity and fairness for women and their families. No longer will families receiving California Work Opportunity and Responsibility to Kids (CalWORKS) assistance be denied benefits for their newborns.

Everyday access to birth control and reproductive health care has been made easier by two measures. One allows women to get a year's supply of hormonal birth control at one time, knowing that it will be covered by insurance. Another affords women and men the opportunity to obtain reproductive health care coverage or services without a referral or prior approval.

Expectant and parenting teens should get the accommodations needed to succeed in school after absences due to maternity or paternity, or abortion.

The chances of that happening are greatly

increased because of a bill that sets requirements and financial incentives for school districts to honor the rights of such students, and to establish appropriate policies for these students.

Another legislative measure will increase access to health insurance through Covered California for our immigrant populations (without public subsidies), although not until 2019.



Queen Sugar by Natalie Baszile

The original book was mostly autobiographical and a labor of love over 11 years. A single mom left her Los Angeles lifestyle and moved on a transformational journey to an 800 acre Louisiana sugar cane plantation during this era. She comes lacking any information as to sugar cane farming with all of its hazards. Her return is to a very large extended family with its reunions, advice and love. Dialogue moves rapidly. Things happen and she enchants you with her new lifestyle. Her half-brother, Ralph, complicates things. But her grandmother, Miss Honey, supports him in all things. In my view, do not see the movie of this lovely book. The movie version alters the book beyond recognition.

After receiving a master's degree from UCLA and an MFA from a writer's work shop, Baszile has certainly produced a successful book. She explores the various struggles especially related to a woman in this field and a black woman at that.
