## PUBLIC POLICY By Elaine Sierra, Public Policy Chair

### California Advances for Reproductive Health and Justice



The 2014 legislative calendar is drawing to a close, with significant advances to celebrate—and some disappointments. Thank you, everyone who joined us in advocating for passage of bills we identified as important to women's health and rights. Thank you for expressing your concern in so many areas affecting access to birth control and abortion, and freedom from sexual exploitation and repression. Among the bills passed and signed by Governor Jerry Brown, we can count as victories those that:

1. Require California insurers to cover all forms of contraception and sterilization approved by the U.S. Food and Drug Administration (FDA), thus ensuring that women can choose their preferred birth control methods and obtain them without out-of-pocket costs. (SB 1053)
2. Protect against eugenics-style sterilizations at the hands of prison doctors, by banning sterilizations in the prison setting for the purpose of birth control, and setting up safeguards against abuse for medical-purpose sterilizations. (SB 1135)
3. Require California state colleges and universities to strengthen their policies and

protocols on sexual assault, domestic violence, dating violence, and stalking. That includes adopting an affirmative consent standard (so that only "Yes" means "Yes") in determining whether a person asserting a complaint gave consent to an alleged rape or sexual assault; and implementing comprehensive prevention and outreach programs. (SB 967)

In addition, the California Senate passed a symbolic resolution that reaffirms its commitment to women and their fundamental right to choice, by stating the Senate's support for US Senate Bill 2578 (Not My Boss's Business Act), which would overrule the Hobby Lobby decision by the U.S. Supreme Court. (That case resulted in allowing a non-religious, private employer to refuse to provide birth control coverage otherwise mandated under the Affordable Care Act (Obamacare), based on a claim of infringement of religious rights.) (SR 55)

While we applaud these accomplishments, we must also acknowledge legislative defeats—advances we must continue to work toward. Chief among them are bills that would have:

1. Strengthened the Attorney General's authority over hospital mergers to protect public access to healthcare services. It would have addressed the problem of hospitals that merge with Catholic or other religious-based health systems and then violate conditions aimed at insuring that the pre-merger level of care for women's health is maintained, at least for some period of time—services such as emergency contraception in cases of rape, vasectomies, and abortion services. (SB 1094 –vetoed by the Governor)
2. Protected the health and safety of children born into poverty, and ended California's intrusion into the private reproductive and medical decisions of poor families. Currently, California Work Opportunity and Responsibility to Kids ( CalWORKS) assistance is barred for any child born into a household when any member is receiving aid—commonly known as the Maximum Family Grant rule. (SB 899 – failed to move beyond a crucial funding committee).



## RECOMMENDED READS By Marlene Katz, Donor Relations

### *PRO: Reclaiming Abortion Rights,* a book by Katha Pollitt



New York Times Book Review, reviewed in The NY Times by Clara Jeffery, October 12, 2014. Summary of some of the facts as given by Pollitt.

For anyone who reads *The Nation* magazine, you will recognize Katha Pollitt as a columnist and poet for that magazine. Her new book as

mentioned above is fresh off the press. Some capsule statements gathered will likely create some curiosity as to what else it contains concerning the antis and their hypocrisy(ies).

- six out of 10 women today get abortions
- abortion is safe, legal, and a million procedures a year are completed
- one half of all pregnancies are unplanned
- her message is that abortion should come out of the closet: she regards it as a social good.
- her interesting observation is that there is a "muddled middle" who don't want it banned but have deeply

conflicted views—and neither do they want it offered

- she says that the Bible does not ban abortion and neither did the founding fathers
- then, too, she notes the hypocrisy the opponents have noted of anti-abortionists
- this line is so true: "there are so many who would reduce women to 'potting soil' if left to their own devices"

Ms. Pollitt also covers the historical background of certain times in history, regarding abortion and the Supreme Court in the mix. Her own family was involved with abortions, even her mother who had a mysterious abortion in her forties.

A writer of 20 plus years ago, Susan Faluda, who wrote the book *The Backlash: the Undisclosed War Against American Women*, published a book at the time of the Anita Hill proceedings with Clarence Thomas. Pollitt alludes to this book in her publication.
